Candidates should submit their downloaded duly filled in Application form with all the required supporting documents along with the details of payment of Rs.1000/- (Rupees One Thousand only) towards the application cost i.e, with SBI collect transaction ID (Copy of receipt to be enclosed). The Procedure of online payment is mentioned in clause 26 of the Prospectus.
- 2. The admissions in the State of Tamil Nadu are as per the provisions of the Government of Tamil Nadu and in compliance to the National Commission for Indian System of Medicine (NCISM) and the National Commission for Homoeopathy (NCH) and shall be solely based on marks obtained in the National Eligibility-Cum-Entrance Test (NEET (UG) 2024) conducted by the National Testing Agency (NTA).
- As per the prevailing regulations, the seat matrices for admission in the Self-Financing Institutions shall be fifteen per cent for the All India Quota and eighty five per cent for the State Quota for the academic year 2024-2025. Further Apportionment of seats between Government and Management of Self-Financing Minority and Non-Minority Indian Medicine and Homoeopathy Medical Colleges will be as per existing State policy and NCISM / NCH Regulations.

1 ELIGIBILITY CRITERIA: -

Candidate should be a citizen of India.

2 AGE LIMIT (As per Clause 16.1.1.c. of NEET UG-2024 Bulletin)

Candidates should have completed the age of 17 years at the time of admission or should complete that age on or before 31st December of 2024 and there is no upper age limit.

3 EDUCATIONAL QUALIFICATIONS:

- (i) Admissions to all State Quota seats of Undergraduate Ayurveda, Siddha, Unani and Homoeopathy Courses will be done through NEET (UG) 2024 as per the provisions of the National Commission for Indian System of Medicine (Minimum Standards of Undergraduate Ayurveda Education), Regulations 2022, National Commission for Indian System of Medicine (Minimum Standards of Undergraduate Siddha Education), Regulations 2022 and National Commission for Indian System of Medicine (Minimum Standards of Undergraduate Unani Education), Regulations 2022 and National Commission for Homoeopathy (Homoeopathy Graduate Degree Course BHMS) Regulations 2022 (NCISM & NCH are Regulatory Bodies of the above-mentioned Courses under the Ministry of AYUSH).
- (ii) In order to be eligible for admission to BSMS / BAMS / BHMS Degree courses for this academic year, it shall be necessary for a candidate to obtain minimum of marks at 50th Percentile in NEET UG 2024 in General Category. However, in respect of candidates belonging to BC / BC(M) / MBC / DC / SC / SCA/ ST, the minimum marks shall be at 40th Percentile in NEET UG 2024. In respect of candidates belonging to Persons with Benchmark disabilities alone the minimum marks shall be at 45th Percentile for General Category candidates and 40th Percentile for BC /BC(M) / MBC / DC / SC / SCA/ ST candidates in NEET UG-2024.

Note:

Provided further that where sufficient number of candidates in the respective category fail to secure minimum marks in the National Eligibility – cum – Entrance Test held for any academic year for admission to undergraduate programme, the National Commission

- for Indian System of Medicine & National Commission for Homoeopathy, in consultation with the Central Government may at its discretion lower the minimum marks required for admission to undergraduate programme for candidates belonging to respective category and marks so lowered by the Central Government shall be applicable for that academic year only.
- (iii) Further, to be eligible for admission to BSMS / BAMS / BHMS Degree courses, Candidates must have passed in all the subjects of the qualifying examination of the Higher Secondary Certificate Examination (Academic) conducted by the Tamil Nadu State Board or any other equivalent Board with the subjects of Physics, Chemistry, Biology / Botany and Zoology and English individually and must have obtained minimum of **fifty percent** of marks taken together in Physics, Chemistry, Biology / Botany and Zoology at the aforesaid qualifying examination in the case of general category and **forty percent** mark in the case of BC /BC(M) / MBC / DC / SC / SCA/ ST category. In respect of **Persons with Benchmark disabilities** candidates the minimum qualifying marks in the said qualifying examination in Physics, Chemistry, Biology / Botany and Zoology shall be **forty five percent** in the case of general category and **forty percent** in the case of BC /BC(M) / MBC / DC / SC / SCA/ ST.
- **NOTE:-** Candidates who have passed any other equivalent examinations other than the Tamil Nadu State Board Examination, CBSE and ICS with same subjects as mentioned above in clause **3** (**iii**) should produce the eligibility certificate from the Tamil Nadu Dr. MGR Medical University before the counselling date or before attending the counselling.
- (iv) Candidates qualified in the NEET (UG) 2024 and who have passed the qualifying examinations from *National Institute of Open Schooling* or *State Open Schools* or *as private candidates* from recognized State Boards; or with Biology/Biotechnology as an additional subject shall be allowed but subject to the outcome of Special Leave Petitions/ Appeals filed by the Medical Council of India. (As per NEET (UG) 2024 Guidelines)
- Note: * "The proviso in italics has been a subject matter of challenge before the Hon'ble High Court of Delhi, Hon'ble High Court of Allahabad, Lucknow Bench, and Hon'ble High Court of Madhya Pradesh at Jabalpur. The provisions of the regulations disqualifying recognized Open School Board candidates and the candidates who have studied Biology/Biotechnology as an Additional subject has been struck down."

(v) Language qualification for BSMS Course

In addition to the required minimum percentile in the NEET UG-2024

- 1. The candidate should have studied in Tamil medium up to X or XII Standard, or
- 2. The candidate should have studied Tamil as a subject up to X or XII Standard, or
- 3. The candidate must be prepared to pursue the study of Tamil Language as a subject during the First-year course of B.S.M.S. course, to become eligible to take the other subjects' examination of the B.S.M.S. Course.
- (vi) Candidates native of other states will be considered as Open Category and they should fulfill the eligibility criteria of Open Category (OC) as per NCISM norms.

4 ELIGIBILITY FOR MINORITY SEATS:

- The candidates who are eligible to claim Linguistic Minority Seats reflecting their Mother
 Tongue should produce the Study Certificate issued by the Head of the Institution last
 studied Annexure -V (a) or a certificate issued by the competent Revenue Authority of
 the candidate's native jurisdiction Annexure V (b).
- 2. The candidates who are eligible to claim Religious Minority seats / Linguistic Minority seats, which is a NOTIFIED MINORITY COMMUNITY AS PER Section 2 (c) of National Commission for Minorities Act, 1992 should produce the Study Certificate issued by the Head of the Institution last studied Annexure -V (a) or a certificate issued by the competent Revenue Authority of the candidate's native jurisdiction Annexure V (b).

The candidates submitting these Annexures in full form alone will be given preference in Minority Colleges as per their minority status.

5 INELIGIBILITY CRITERIA:

The following categories of candidates are **NOT ELIGIBLE** to apply for B.S.M.S. / B.A.M.S. / B.H.M.S. Courses.

- a. Candidates who have passed Higher Secondary Education in Vocational Stream *or* who have passed Pre-University Course in Tamil Nadu.
- b. The selection and admission of candidates of other than those in clause 3 (iii) will be provisional subject to recognition of the qualifying examination by the Tamil Nadu Dr. M.G.R. Medical University under which the candidate gets admitted. In case, the recognition is not accorded for the admission of the candidate on any grounds, the provisional admission will not entitle the candidate for the continuance of the course and the admission will be cancelled.
- c. Candidates presently pursuing the B.S.M.S. / B.A.M.S. / B.H.M.S. / B.U.M.S. Courses are NOT ELIGIBLE to apply for the same Course during this academic year.
- The tentative lists of Self-Financing Indian Medicine and Homoeopathy Medical Colleges are furnished with the details of Courses offered and Tentative seats available under Management Quota in the Annexure I respectively.

7 DURATION OF THE BSMS / BAMS / BHMS COURSES:

5 1/2 years of study including one year Compulsory Rotatory Residential Internship.

8 METHOD OF SELECTION AND ADMISSION:

- (i). The admission shall be made on the basis of National Eligibility-cum-Entrance Test **NEET UG-2024** score and NEET Rank for B.S.M.S. / B.A.M.S. / B.H.M.S. Courses for the year 2024-2025 for the Seats under Management Quota in Self Financing Indian Medicine and Homoeopathy Medical Colleges.
- (ii). Rank List of the eligible candidates shall be prepared on the basis of the marks obtained in **NEET UG-2024** and candidates shall be admitted to the above courses from the said rank list only. Further Secretary, Selection Committee will publish the tentative rank list on the following official website: www.tnhealth.tn.gov.in
- All selections and admissions for BSMS / BAMS / BHMS Courses are only provisional. The Selection and admission is liable to be cancelled at any time as and when the eligibility conditions are found to be defective or incorrect or of any suppression of facts deliberately or otherwise. The right of allotment to BSMS / BAMS / BHMS courses and Colleges is vested totally with the Selection Committee.

10 | COUNSELLING (Single Window System):

SELECTION COMMITTEE:

- a. Selection Committee is the designated authority for counselling for all admissions to Undergraduate courses in Siddha, Ayurveda, Homoeopathy and Unani Medicine in all Government, Self-Financing AUSH Institutions of Tamil Nadu. (except for government seats in AIQ)
- b. No authority or Institution shall admit any candidate to the Undergraduate course in contravention of the criteria or procedure as laid down by NCISM / NCH in respect of admissions and any candidate admitted in contravention of the said criteria or procedure shall be discharged.
- c. The authority or Institution which grants admission to any student in contravention of the criteria or procedure shall be liable to face action in terms of provisions of the NCISM and NCH regulation 2022.

Selection will be made based on NEET UG-2024 score and by following Single Window System during counselling. Counselling schedule will be available only on the official website: www.tnhealth.tn.gov.in

- (i) Candidates should attend the counselling session as per the schedule and as per their rank as mentioned in the official website: www.tnhealth.tn.gov.in only.
- (ii) One of the Parents or Guardian will be allowed to accompany the candidate to attend the counselling and they should make their own arrangements for attending the counselling session.

 Use of Mobile Phones will be strictly prohibited in the Counselling Hall.
- (iii) Candidates will be called for counselling as per their rank and they may exercise their option as per their eligibility norms mentioned in the Prospectus.
- (iv) Option once exercised during counselling, will be final and cannot be changed.
- (v) Candidates who fail to attend the First Phase counselling at the specified date and time will not be permitted to attend the subsequent phases of counselling. The candidates will forfeit their right to admission and their names will not be considered later. However he / she can authorize his / her parent on his / her behalf for that phase of counselling due to unavoidable circumstances and the parent's decision will be binding on the candidate. An Authorization letter given by candidate should be submitted by the parents along with the original documents of any one of the identification proof such as Voter ID, Driving Licence, Pan Card / Passport of both the parent and the candidate as mentioned in the Annexure IVa and IVb.

- (vi)Rules as applicable for the Management Quota seats as per the prevalent NCISM/CCIM / NCH / CCH rules and regulations, State Policy and the relevant rules of Institutions applicable to the Self-Financing Management Quota will apply.
- (vii) (a) All Communications regarding Counselling will be displayed / available through the official website only and any change or modification and relevant information pertaining to this admission process will be made available immediately on the website www.tnhealth.tn.gov.in.
 - (b) The candidates are instructed to visit the website at least two times a day for updates from the date of issue of application till the end of admission process without fail. Selection Committee will not be responsible for consequences resulting due to non-diligent follow-up of notices, notification and publications appearing on the website regarding admission to B.S.M.S. / B.A.M.S. / B.H.M.S. Courses under Management Quota 2024-2025 session.
- (viii) (a) Candidates can exercise their option for the course and the college of their own choice at the time of counselling, and allotment is subject to availability of seats.
 - (b) Individual request for transfer of College or change of course will not be entertained after allotment of seat is made during same phase of counselling. A candidate is eligible for Re-allotment only during subsequent phase of counselling based on rank and one should have joined the Self-Financing College to which one was allotted under Management Quota during earlier phase of counselling.
- (ix) (a) The vacancies arising after the first phase of counselling will be filled up from the waiting list through counselling.
 - (b) Also Counselling / Allotment for the seats newly created due to provision of seat matrix after the commencement of first phase counselling by the Tamil Nadu Dr. MGR Medical University or due to the orders / interim orders passed by the Honourable High Court of Madras after the commencement of 1st phase counselling will be done *ONLY* during the 2nd phase of counselling but within the cut-off date for UG Courses admission as laid down by the regulatory bodies i.e., NCISM/CCIM & NCH/ CCH / Ministry of AYUSH.
- (x) Mutual transfers will not be allowed under any circumstances.
